TRAVELLER'S CONSENT ON BOOKING, PAYMENT, CANCELLATION, AMENDMENT, REFUND POLICY & OTHER CONDITIONS

I confirm having received sufficient information about the Mt Kailash Aerial Darshan Yatra from Max Holidays and I have cross verified the same to meet with my satisfaction. While completing my booking with Max Holidays for this trip, I confirm to abide myself by the following booking, payment, cancellation, refund and other policies which are pre-informed to me. I have also read and understood all other Booking Conditions and Terms of Services of M/S Max holidays as published on their website www.kailash-yatra.org and also in their trip brochures.

Payment Terms:

- At the time of booking INR 10,000/- each traveller (including Non-refundable amount INR 5,000/+18%GST)
- Balance payment is to be made 45 days prior the trip commencement date. Late payment may result forced cancellation and full advance payments will be forfeited.

Cancellation / Date Change Fee:

- If cancelled more than 45 days before trip date – INR 5,000/ + 18% GST will be charged
- Within 44-21 days before trip date – 50% of total trip cost will be charged
- Within 20-15 days before trip date – 70% of total trip cost will be charged
- Less than 15 days before trip date – No refund applicable / Full trip cost will be charged

Special Remark: For bookings made under a promotional/discounted plan payment, cancellation and refund conditions will be different as communicated during bookings.

Important Cost Exclusions

I (NAME) HAVE BOOKED ONE SEAT FOR MT. KAILASH DOOR DARSHAN GROUP TOUR WITH MAX HOLIDAYS WHICH PROVIDES AERIAL DARSHAN OF THE HOLY MOUNT THROUGH A CHARTER FLIGHT. I CONFIRM:

1. THAT, I HAVE BEEN INFORMED BY THE COMPANY THAT A CLEAR VIEW OF MOUNT KAILASH FROM THE FLIGHT WILL BE SUBJECT TO WEATHER CONDITIONS AS THE COMPANY WILL HAVE NO CONTROL OVER THE SAME.
2. DUE TO ANY REASON (INCLUDING WEATHER CONDITIONS) IF THE FLIGHT DOES NOT GET PERMISSION TO TAKE OFF AS SCHEDULED, THE COMPANY SHALL ARRANGE FOR THE SAME ON THE FOLLOWING DAY. INCASE, THE FLIGHT DOES NOT TAKE OFF AT ALL DUE TO ANY REASON EVEN OF THE SECOND DAY, I WILL BE ENTITLED FOR A REFUND OF INR 13,500/- (WINDOW SEAT) OR 8,000 (NON-WINDOW SEAT). HOWEVER THERE WILL BE NO OTHER REFUND OR ADJUSTMENT APPLICABLE FOR ANY USED OR UNUTILISED SERVICE/S OF THE TRIP AFTER THE TRIP HAS LAUNCHED IN LUCKNOW.
3. I HAVE PURCHASED ONE SEAT IN THE FLIGHT FOR ONE FLIGHT DEPARTURE. I KNOW THAT ONCE THE FLIGHT HAS TAKEN OFF FROM NEPALGUNJ AIRPORT, THERE WILL BE NO REFUND APPLICABLE EVEN IF VIEW WAS NOT CLEAR OR THE FLIGHT RETURN DUE TO SECURITY / SAFETY / TECHNICAL REASONS.
4. THIS IS A GROUP TOUR ON SHARING BASIS AND THE COMPANY SHALL HAVE THE FINAL AUTHORITY TO TAKE DECISION ON ANY AND ALL ASPECT OF THE TRIP IF AND WHEN REQUIRE. I WILL ACCEPT THE DECISION OF THE COMPANY MANAGEMENT TAKEN IN THE FAVOUR OF THE GROUP.
